#### 1. RECOMMENDATION OF USE

Please read the complete instruction manual before using the Q-Rejuvalight Pro Facewear. It will give you a better understanding of how the product works, and you'll be able to enjoy the best treatment results.

# 1.1. Warnings

- Prior to using this device, please carry out a sensitization test (see section 4.3).
- · Do not look directly at the light source during the treatment.
- Do not harshly bend, sit or stand on the device. Do not harshly bend or abuse the wire and port of the USB charging cord.
- Do not operate the device where it could come in contact with water. In case of accidental
  contact with water, avoid touching the device before you unplug it.
- · Do not attempt to modify this device. Device is not serviceable by the user and can void warranty.
- This device contains a Lithium Ion Battery. Before disposal of this device, please review your local laws and requirements surrounding Lithium Ion Battery disposal.
- Discontinue use if the device overheats or becomes uncomfortably hot.
- · Always unplug the device from the outlet after charging is complete.
- Keep the device away from flammable liquids, aerosol products to prevent potential hazards.
- Stop using the device immediately if you think it is defective, please contact customer support.
- · Use only accessories provided with this device to avoid unintended electromagnetic effects.
- This device has been tested for radiated RF immunity only at specific frequencies, when used near
  emitters at other frequencies, unexpected treatment results will be caused.
- If there is sunburn in the past 2 weeks, do not use this device.
- Ensure to remove all creams, serums, lotions, and make-up prior to treatment.



Some ingredients in these products may cause light sensitization or may reduce the effectiveness of the treatment.

# 1.2. Contraindications (Do not use if any of the following occur)

- · This device is designed for use on adults and not recommended for use on infants or children.
- This device is best suited for Fitzpatrick skin types I to IV. Consult with your dermatologist before
  using this device if you have skin types V and VI. This step is crucial as skin reactions can vary from
  person to person, and what works well for one individual may not be suitable for another.
- Do not use this device to treat any other conditions apart from those listed in the indications for use. This device has not been tested for any other conditions than those listed, and the risk is unknown.
- Do not use this device if you are photosensitive or are taking photosensitive drugs. If you are
  unsure about any medication you may be taking, consult your healthcare provider.
- · Do not use the device if you are pregnant, or breastfeeding, or planning on becoming pregnant.
- · Do not use the device if you have a medical history of seizures that were triggered by light.
- For individuals with severe acne, it is recommended to consult with a healthcare professional to see if this device is suitable for use.
- Do not use this device to treat skin that is painful to touch, raised (higher than surrounding skin), crusting or bleeding. This may be a sign of a more serious condition and should be checked by your doctor.

### 1.3. Adverse Reactions

This product may cause a photosensitive reaction, if you suffer the photosensitive reaction, please stop use immediately and consult your physician.

If you experience any discomfort, skin discoloration, or any other concerns develop, stop using immediately and consult your physician.

### 1.4. Precautions

- Read all instructions carefully before use and only use this device as described in the manual to
  ensure your safety and to maintain warranty.
- Use a 5V adapter to charge the device to avoid automatic shutdown of the charging function when an adapter greater than 5V is used.
- This device cannot be used during the charging process. To ensure a seamless experience fully charge the device before use.
- · Stop using this device if you experience any adverse reactions and consult a medical professional.
- If you are taking steroids or NSAIDs, avoid using the device to prevent potential photosensitive reactions.
- Do not use this device if you have received a steroid injection in the past 6 months, because it may result in a photosensitive reaction.
- Ensure optimal performance by avoiding environments where other devices emit unshielded electromagnetic energy.
- · Preserve the device's functionality by avoiding scratching or damaging the light-emitting surface.
- Do not use the light to shine directly into the eyes of others. Always use eye protection during treatment and use the goggles provided.

- Prior to each use, inspect the device for any signs of damage.
- Store the device according to the suggestions listed in the manual to preserve its functionality and efficacy.
- In case of electromagnetic interference, follow the instruction manual to reset the product. If issues persist, consider using the device in another location for uninterrupted use.

### 2. INTENDED USE & INDICATIONS FOR USE

The Q-Rejuvalight Pro Facewear (Model: P19-0023) is an Over-the-Counter (OTC) device intended for treatment of wrinkles and mild to moderate inflammatory acne.


### 3. PRODUCT DESCRIPTION

The Q-Rejuvalight Pro Facewear is an over-the-counter light emitting diode (LED) device that emits energy for use in dermatology for the treatment of wrinkles and mild to moderate inflammatory acne. The device uses four types of LEDs for Anti-Aging: 605nm, 630nm, 660nm, and 880nm and two types of LEDs for Anti-Breakout: 415nm and 630nm. Each mode takes 3 minutes (±3s) for a course of treatment, and the mask will automatically turn off at the end of time.

The package components include the Q-Rejuvalight Pro LED mask device, head strap, protective eyewear, latch, user manual, storage bag and charging cord.

The Q-Rejuvalight Pro Facewear is applied directly to the skin to ensure consistent administration of light during each treatment. The device does not contain any user serviceable components.

# 3.1. How Qure's Light therapy Technology Works



Q-Rejuvalight Pro Facewear delivers safe, concentrated wavelengths of natural light directly to the underlying layers of your skin, with no chemicals, UV rays, or excess heat, with clinical-grade LEDs to power up your skin cells.

#### **Treatment Modes**

Q-Rejuvalight Pro Facewear is programmed with a 3 minute automatic shut-off function for anti-aging and acne-fighting results with quick, convenient, daily treatments from the comfort of your own home producing transformative results in less than 12 weeks.

Q-Rejuvalight Pro Facewear offers three (3) different treatment modes:

- Anti-Aging
- · Anti-Breakout
- Custom zone selection on five facial areas

### **Anti-Aging Treatment**

Collagen protein makes up 30% of the total protein in the body, and 70% of the protein in the skin! As a person ages, the epidermis (outer layer of skin) becomes thinner and loses elasticity through a process called elastosis. As this happens, a person tends to show more signs of aging.

Qure's Anti-Aging Treatment uses a combination of red, deep red, amber and infrared light to naturally stimulate production of collagen and elastin.

The benefits are numerous;

- Smooth wrinkles and fine lines.
- Brightens and evens complexion.
- Increases collagen production.

- Promotes healing and recovery.
- · Decreases redness and inflammation.
- Fades dark spots and hyperpigmentation.

#### **Anti-Breakout Treatment**

Qure's Anti-Breakout treatment combines both Red and Blue Light therapy technology to treat mild to moderate acne, killing the acne-causing bacteria. It eliminates the bacteria found in the oil glands of the skin and regulates oil production. The result is less oil in the skin and less bacteria, leading to less acne in the treated areas

It also clams redness and inflammation, whilst helping fade post breakout hyperpigmentation marks.

### What To Expect:


Depending on what skin concern you're trying to treat - Users can see initial results within 2 weeks, with the best results occurring after a 12 week course of treatment when used daily.



## 3.4. Description and Features



### **Explanation for button**

Q-Rejuvalight Pro Facewear has only one power button, and its functions are as follows:

- Turn on/off the device:
  - Turn on the device by pressing the power button (for 2-3 seconds), and the indicator will illuminate when the device is powered successfully.

- You can turn off the device in advance by pressing the power button (for 2-3 seconds). Or it will
  automatically shut down when the treatment time for 3 minutes is over. And the indicator will
  light off when the device is powered off successfully.
- Select the Mode:
  - After the device is powered on successfully, shortly press the power button to select the
    Anti-Aging mode, which is intended to treat wrinkles with four wavelengths, and shortly
    pressing the power button again to change to Anti-Breakout mode, which is intended to treat
    mild to moderate inflammatory acne with two wavelengths.

### **Explanation for indicator**

- The indicator will illuminate solid during the normal working, and the when the battery is in low power, the indicator light will flash.
- During charging, the indicator will flash, and when the battery has been fully charged, the indicator light will turn off.

### 4. HOW TO USE INSTRUCTIONS

# 4.1. Check for your skin type and condition before use

1) Please distinguish your skin type according to the below table before use, which will provide more effective instructions for your choice.



This device is best suited for Fitzpatrick Skin Types I-IV.

It's crucial to note that Fitzpatrick Skin Types V and VI are more sensitive for light therapy as they can absorb more light than other skin types as they have higher levels of melanin in the skin. For customers with skin types V and VI, we highly recommend consulting with your dermatologist before using the device.

2) Please distinguish your acne level according to the below table before use, which will provide more effective instructions for your choice.

Acne Type	Description	Reference	
Mild Acne	One or several pimples and redness in small areas		
More pimples and more redness over a wider area			
Severe Acne  Widespread pimples and redness with pus-filled spots. May have hard bumps under the skin. Many whiteheads and blackheads.			

## 4.2. Device set up and first use preparation

- Unpack the package and check off all the parts described in section 3.2. 1)
- 2) The device typically arrives pre-charged. To verify its battery level, press and hold the power button (for 2-3 seconds) to turn it on. If the indicator illuminates solid, then use the device until the battery is low.
- 3) If the indicator light flashes when turning the device on, then proceed to charge it before use.
  - Connect the Type C interface of power cord to the device.
  - Connect the Type A interface of power cord to the adapter.
  - Plug the adapter into the power outlet (Please note the adapter input: 100-240Va.c., 50Hz/60Hz, output: DC 5V, 1A) to power supply the device.
  - During charging, the indicator will flash. When the battery is fully charged, the indicator will turn off.

Note: (Adapters are not provided with this device. The recommended AC adapter should be certified by IEC/EN 60601-1 or IEC/EN 62368-1.

# 4.3. Light sensitivity test

Before carrying out your first treatment, you must carry out a light sensitization test. Follow the guide below:

- Apply the Q-Rejuvalight Pro to the inner forearm making sure the light is shining onto the skin.
- 2) Press the power button until the indicator light is illuminated, then press again to activate LED treatment. Allow the device to run for a full 3-minute treatment. At any time if your skin feels hot or uncomfortable, immediately turn OFF the device and remove from skin.
- 3) After the treatment, wait for 24 hours. If you experience pain or discomfort, or redness that lasts

for more than 2 hours, you might be light sensitive. Please consult a doctor for advice prior to use.

# 4.4. Operation Instructions

- 1) Thoroughly clean your facial skin to remove all traces of dirt, skincare and makeup.
- 2) Insert the protective eyewear and attach the head strap to the device.
  - a) Align the Q-Rejuvalight Pro so the LED lights face towards you.
  - b) Insert the protective eyewear into the designated slots in the Q-Rejuvalight Pro Facewear.



- c) Slide the strap through clip 2. The Qure logos on the strap are facing towards the LED lights.
- a) Insert the strap through the slide adjuster. The Qure logos on the strap should be facing you.
- e) Slide the strap through the outside of clip 1, push the latch through the end of the strap, and secure the latch by pulling the strap so it's secure on the inside of the mask clip.



- 3) Position the Q-Rejuvalight Pro on your face and use the slide adjuster to comfortably fit the strap, ensuring the mask remains in place.
- 4) To choose/change the treatment, follow the instructions below:
  - a) Power on the device by pressing the power button (approximately 2-3 seconds) until the indicator light illuminates.
  - b) Press the button once for Anti-Aging Treatment.
  - c) Press the button again for Anti-Breakout Treatment.
- 5) The device will automatically turn off after completion of 3-minute treatment. You can power off the device by pressing the power button (approximately 2-3 seconds) until the indicator light turns off.
- 6) Remove Q-Rejuvalight Pro Facewear from face and wipe device clean (see Section 5 cleaning instructions).
- 7) Place Q-Rejuvalight Pro Facewear into the provided luxury bag and store the device flat at room temperature in dry conditions.

You can also use the Q-Rejuvalight Pro Facewear in combination with the Qure Skincare App, see next chapter for detailed instructions.

#### Note:

- It is recommended to undergo a 3-minute treatment per day; overtreatment is not advised.
- Avoid using makeup during treatment, as cosmetics containing chemical or acidic components may affect light output and result in decreased or ineffective treatment.
- During treatment, please use the straps to secure the device to the face properly.

Being the world's first customizable LED mask and also the only one to have a compatible mobile app, Qure empowers you to embark on a skincare journey that's truly yours.u might be light sensitive. 

## 4.6. How to operate the Q-Rejuvalight Pro Facewear with the Qure Skincare App

#### Phase One:

- 1) Download the Qure Skincare app.
- 2) Open the app on your mobile device and follow the instructions to set up your profile.
- 3) Pair your Q-Rejuvalight Pro Facewear with the app by turning ON your Bluetooth on your phone.
- 4) Turn ON the Q-Rejuvalight Pro Facewear by holding the power button on the forehead until the indicator light is on.
- Inside the app the Q-Rejuvalight Pro will appear on the available devices list, click on it to connect.
- 6) Start treatment will appear in the app when it's paired.

### **Phase Two:**

- Follow steps 1 to 3 of sections '4.4. Operation Instructions' to prepare yourself and the Q-Rejuvalight Pro Facewear for the treatment session.
- 2) Follow the instructions in the app to start and customize your treatment. You can choose from three (3) treatment options: Anti-Aging, Anti-Breakout or custom zone.
- 3) Click 'start' to start your treatment.
- 4) The device will automatically turn OFF after completion of 3-minute treatment.
- 5) Remove device from face and wipe device clean (see cleaning instructions).
- 6) Store Q-Rejuvalight Pro in the provided protective storage bag.
- 7) After treatment, apply topical skincare.

### 5. MAINTENANCE

# 5.1. Cleaning

The device is reusable, and it needs to be cleaned after each use. The cleaning methods of the device are instructed as follows:

- 1) Turn Q-Rejuvalight Pro Facewear OFF and make sure it unplugs from any power source.
- 2) Wipe the inside of the mask with a damp cloth (make sure the cloth is not too wet as it might damage the electrical components) to remove any residue from skin oils after each use.
- Clean Q-Rejuvalight Pro Facewear body by using a damp or microfiber cloth. Do not use chemical or alcohol-based cleansers on the exterior.
  - **Note:** Check the device whether some visible contaminants still exist. If there are visible contaminants on the device, repeat the above steps.
- 4) Dry the device in air naturally, and make sure that the device is dry completely prior to use or store in the storage bag.

Note: Do not use any other cleaning products as these may damage the plastics.

### Warning:

- DO NOT immerse the product in liquid.
- DO NOT dismantle the housing of the unit by yourself.
- DO NOT drop the device or apply external pressure onto the unit since this may damage or weaken the LEDs and other components.
- Once the cord or device is damaged or does not operate normally, contact the distributor. This
  device only is serviced, repaired, and disassembled by Light Tree Ventures Europe B.V. . All units
  should be returned to the manufacturer for repair, including Warranty repair and Out-Of-Warranty
  repair, please do not disassemble or repair the returned units by yourself.

# 5.2. Troubleshooting

In the event that the device fails to perform as intended, the following notes will help to identify potential problems with the device and its setup.
